Foreword by Ronan King, Chairperson of the Private Security Authority

I am pleased to introduce the 2010 Report of the Private Security Authority. 2010 was another successful year for the PSA across all its operational areas.

Despite economic difficulties throughout the industry, the PSA received the highest number of individual applications since 2007 when licensing was initially launched. Our processing has been significantly re-designed since then and the PSA can now issue licences faster and with significantly fewer resources than were originally assigned to the PSA.

With the launch of identity cards last year and our continued on the ground inspections there has been a noticeable increase in compliance rates by those working in the industry. Compliance with individual licensing now stands at 95% for security guarding and at 85% for door security. This is in comparison to figures of 92% and 82% respectively at the end of 2009. 2010 also saw the completion of a Requirements Document for CCTV Installation which paves the way for the licensing of CCTV installers.

At the same time 2010 was a difficult year both for the PSA and the industry. As reported last year trading conditions for all firms in the industry continues to be very difficult with ongoing pressure on pricing. For the PSA, limited resources have delayed the introduction of licensing of CCTV installers and of staff working for Cash in Transit companies until 2011. This was a difficult decision but was taken so as to safeguard our existing core licensing and to ensure that we had sufficient capabilities to monitor standards compliance in areas already licensed.

Based on PSA recommendations, the Minister has included a number of amendments to improve PSA operations in the Miscellaneous Provisions Bill 2010. This Bill on enactment will give the PSA more flexibility in the deployment of resources. It will also facilitate the PSA completing its statutory mandate through regulation of the remaining areas of the industry.

This completion of the roll out of licensing was a key driver of the review of the first strategy statement of the Authority and the preparation of a new strategy for the period 2011 to 2013. This new strategy will build on the successes of the past in further raising standards in the industry over the coming years for the benefit of both clients of the industry and the general public.

Improved standards of service delivery affords the opportunity, as has happened internationally, for the private security industry to take on additional responsibilities outside the traditional security remit. At a time of diminishing budgets in all sectors, the industry operating to the highest standards could offer a cost effective solution in areas addressing the needs of both public and private sectors for increased security and safety provision.

The Authority has continued to benefit from the assistance of other statutory colleagues, in particular An Garda Síochána and the Revenue Commissioners. These collaborations continue to play a key role in our day to day monitoring and enforcement roles.

I would once again like to recognise the excellent contributions of the Board and our Executive Team, led by our CEO, Geraldine Larkin, in delivering the PSA achievements throughout 2010.



Introduction by Geraldine Larkin, Chief Executive Officer

I am delighted to introduce the 2010 Annual Report of the Private Security Authority. 2010 marked another busy year for the Authority as it managed increased individual applications and a growing number of prosecutions while at the same time operating under continued budgetary pressures.

In 2010 the PSA received in excess of 13,000 individual applications comprising 6,171 new applications and 7,544 renewals. This renewal rate represents 60% of the original licences during the first round of licensing in 2008. In contrast to the first round of licensing, many of those applying for licences for the first time are not yet working in the industry. This is mirrored by reducing turnovers within the industry and an associated 10% decrease in staffing within licensed contractors. In recognition of the difficult market situation of all contractors and in particular smaller operators, the PSA introduced an instalment arrangement for those having a turnover of less than €150,000 per annum.

A significant milestone was reached in 2010 with the issue of the first Cash in Transit contractor licences. This represents the culmination of significant investment and upgrading by cash in transit providers to bring their services up to PSA standards. The PSA also concluded the Requirements document for CCTV installation in preparation for licensing of that particular security service.

Monitoring of all PSA licences continues and in 2010, 22 contractors' licences were revoked. Of these 19 were for failure to maintain licensing standards. The PSA does not lightly revoke a provider's licence and the decision is preceded by a framework of advices and ways to enable the

contractor rectify the breach. In total 73 such actions were initiated by the PSA against contractors and over 300 against individuals.

Over 850 venues were inspected to check on individual licensing and wearing of the identity badge. Compliance with individual licensing has improved considerably and now stands at 95% for security guarding and at 85% for door security. Despite these levels of compliance, there continues to be an issue with the wearing of the identity badge with 89% of guarding and only 69% of door staff wearing the badge. These levels are not acceptable and a programme of repeat inspections has commenced where non-compliant venues will be targeted and those found in breach of the legislation will have their licences suspended or be prosecuted.

The wearing of the identity badge is critical to raising public confidence in the industry and proving that staff are licensed. The badge also provides a reference point for a complainant in the event there is an issue with the security provided. In 2010 there was an increase in the number of formal complaints received by the PSA although in the majority of cases the complainant refused to be identified and the complaint went no further. The PSA will focus further on this in 2011.

Notwithstanding this, there were a number of significant investigations undertaken by the PSA of its own motion and there is a sample of these cases in the Enforcement report. The cases range from ensuring that one of the largest guarding employers' is 100% compliant with licensing requirements, through co-operation with An Garda Síochána in suspending the licence of a person with a door security licence charged with various offences, to various prosecutions against unlicensed alarm installers following information from industry sources of unlicensed activity. Also included in this year's case review is an account of the interaction with a liquidator appointed to a licensed security guarding company. In this instance the Authority sought to establish that there was a legitimate liquidation of the company and also that the contracts subsequently transferred to licensed security providers.

On an operational basis I would like to acknowledge the co-operation and support received from An Garda Síochána in the day to day activities of our inspectors and in the facilities provided by the Garda Vetting Office in vetting licence applicants. Equally, I would like to acknowledge the assistance of the Revenue Commissioners through the operation of the Memorandum of Understanding which exists between us. I also wish to acknowledge the support of the Minister for

Justice and Law Reform and the staff of the Department who have a key role in ensuring that the necessary legislative framework is in place to underpin regulation.

Finally, I would like to acknowledge the ongoing contribution of the staff of the PSA and their continued innovation in delivering cost effective regulation to the industry. Their efforts saw the introduction of Optical Character Recognition scanning for all individual licence applications, thus giving the capacity to manage the 2007/2008 renewals with one third less staff than during that initial period. Texting renewal information to licensees has also significantly reduced our administrative costs and has delivered a faster service to those about to renew licences.

As always my thanks to the Board of the PSA and in particular to the Chairman Mr Ronan King for his ongoing energy and commitment to ensuring that the PSA delivers effective and cost efficient regulation to the industry and the citizen alike.



Section 1:

Who We Are and What We Do

WHO WE ARE

The Private Security Authority (PSA), established pursuant to the Private Security Services Act 2004, is the statutory body with responsibility for licensing and regulating the private security industry in Ireland. PSA headquarters are based in Tipperary Town, with a team of Enforcement Staff situated throughout Ireland.

The Authority is independent in the exercise of its functions. The Board of the Authority, chaired by Mr. Ronan King, consists of representatives of the legal profession, private security employers and employees, An Garda Síochána and relevant government departments and agencies.

The legislation establishing the PSA identifies 8 broad sectors of security provision that are to be regulated. These sectors are as follows:

- Door Supervisor
- Supplier or Installer of Security Equipment
- Private Investigator
- Security Consultant
- Security Guard
- Provider of Protected Forms of Transport (CIT)
- Locksmith
- Supplier or Installer of Safes

OUR ROLE

Our key role is to ensure that the PSA licence is a living instrument and to prove that licensing standards have not only been achieved but are being constantly maintained by licensees.

- Controlling and supervising people who provide security services and maintaining and improving standards in the provision of those services.
- Granting and renewing licences.
- Issuing identity cards to licensees.
- Suspending and revoking licences.
- Establishing and maintaining a register of licensees.
- Specifying standards to be observed in the provision of security services.
- Specifying qualifications or requirements for the granting of licences.
- Undertaking or commissioning research projects and activities necessary for the planning, development and provision of those services.
- Investigating security services being provided by any person.
- Establishing and administering a system of investigation and adjudication of complaints.
- Monitoring the provision of private security services generally.
- Liaising with licensees.
- Advising the Minister for Justice, Equality and Law Reform on any matters relating to the above functions and keeping the Minister informed of developments that would assist in developing policy.

OUR MISSION STATEMENT

It is the aim of the Authority to use the statutory regulation and enforcement powers provided to it to introduce positive, fundamental change in the private security industry.

- Our purpose is to instil customer and public confidence in the multi-stranded, multi-faceted security industry.
- We are doing this through the introduction, control and management of comprehensive standards driven licensing system for all individuals and companies involved in providing security services.
- We aim to carry out our duties in a manner that is sensitive to the needs of the market and by working with the security industry.



Section 2:

Our Goals

OUR GOALS

The Mission Statement of the Private Security Authority is translated into action through five key goals set out in our first Strategy Statement. In summary these goals are as follows:

Goal 1: We will transform the operation of the Private security Industry through a comprehensive licensing system to increase confidence of all stakeholders.

Goal 2: We will drive the transformation of the industry using a framework of standards for private security providers and qualifications for individuals working for such providers.

Goal 3: We will monitor and control the transformation of the industry through investigation, enforcement, prosecution and a system of quality control.

Goal 4: We will develop an efficient and innovative organisation with motivated and skilled staff supported by appropriate physical infrastructure and facilities.

Goal 5: We will actively participate and pursue our role in the EU and at wider international level, working with other EU and International Private Security Regulators, to contribute to the formulation of policy in this area.

Goal 1:

We will transform the operation of the Private security Industry through a comprehensive licensing system to increase confidence of all stakeholders.

Review

The outputs of this goal are realised in the licences issued by the Authority. 2010 proved to be another critical key year with a number of key milestones reached during the past 12 months.

- The first individual renewal licences issued in January followed by the first contractor Cash-In Transit licences issuing in April.
- In August, the number of applications received since licensing commenced reached 50,000.
- The year also recorded the second phase of renewals for those contractors who were first licensed in 2006.
- Contractor licensing continued apace in 2010 with 477 renewal and first time applications received for 546 sectors. This brings to 2335 the total number of applications received since the introduction of licensing in 2006.
- A total of 13,715 individual applications were received during the year comprising of 6,171 new applications and 7,544 renewal applications. Over 16,400 individual licences and identity cards were issued in 2010, almost double the number issued in 2009.
- Licensing fees for the year totalled €2,827,464 the highest recorded with €1,454,000 relating to contractor licensing and individual licensing accounting for €1,373,464.

General Responsibilities

The Authority issues two types of licence both valid for a period of two years. Contractor Licences are required by companies, partnerships and sole traders providing security services in the Republic of Ireland. Individual Licences are required by all those working in the security sector within the state whether employed by a licensed contractor or directly by a business as in house security personnel.

Licensing – Contractors

During the year a total of 477 contractor applications were received comprised of 119 first time applications and 358 renewal applications. This brings to 2,335 the total number of applications received since contractor licensing commenced in 2006.

46(10%) of all applications received were rejected on receipt as invalid because all necessary documentation was not lodged. 34 of these applications were re-lodged as valid applications leaving 12 cases rejected at the end of the year. A further 12 applications were refused after failing to meet the requirements of licensing.

The first Cash-In-Transit (CIT) licences issued in April and by the end of the year 8 contractors had received licences to operate in 23 CIT sectors. 1 application was refused while 4 contractors are currently having an application processed (This includes 3 contractors already licensed in other CIT sectors).

Change in licensed contractors in 2010

The licences of 437 contractors expired during the year including 385 contractors who were renewing for the second time. 92 (21%) of these failed to renew their licence by the end of the 2010 this compares with 31% in 2009.

There can be a number of reasons for not renewing licences including consolidation in the industry, change in legal status(for example a move from sole trader to limited company) or

business closure. Where the Authority hasn't confirmed the reason for the non renewal the case is referred to the Enforcement team to ensure that the contractor is not continuing to trade.

The volume of licences renewed after the expiry date stands at 26% down from 41% in 2009. The late renewal of licences creates additional demands on the Division's resources. The Division is currently investigating means of reducing the late renewal rate further in 2011.

Revocations and Suspensions

The Authority views a licence as a living instrument and the monitoring of the contractor during the two year licence is an important facet of licensing. The Licensing Division reviews the compliance status of contractors throughout the licence cycle. Failure to maintain the requirements of licensing can result in a licence being suspended or revoked. The decision to revoke or suspend a licence is not taken easily and the Authority will have gone through a long process of engaging with the contractor before reaching this stage.

This year 22 contractors had their licences revoked, while 3 contractor licences were suspended for a period. In addition, 5 Reprimand Notices were issued to contractors with the issue of their licence during 2010. Details of all 2010 revocations are published on our website.

Employment and Turnover

At the end of 2010 there were 757 contractors licensed to provide security services in 5 sectors. Employment by these contractors stands at over 20,300 (2009: 22,499) while the combined turnover as disclosed in application forms exceeds €573 million (2009: €656 million). The figures show a drop in both turnover and employment and reflects the economic impact on the security industry as recorded in applications received during the year.

Appeals

The Private Security Appeal Board received 7 contractor appeals against a decision of the Authority in 2010 bringing to 39 the total number of contractor appeals received to date. 3 of the appeals related to decisions to refuse the application, 3 related to revoking the licence and 1 was in connection with the suspension of a licence.

The Appeal Board held an oral hearing in March of the judicial review case heard before Ms. Justice Dunne in July 2009 in which the court quashed the decision of the Appeal Board. The Board decided to issue a licence.

Exemption Order for Alarm Installers

Since September 2007 new entrants into the Installer (Intruder Alarm) sector can apply for an Exemption Order which allows the applicant install alarms for the purpose of obtaining the Standards EN50131 and SR40. Before an exemption order issues an applicant must meet all the other requirements of licensing. Exemptions normally issue for a period of 6 months and allow for the installation of up to 6 alarms. In 2010, the Division issued 59 exemptions bringing to 176 the total number issued since 2007.

At the end of each quarter the exemptions are published in Iris Oifigiúil and on our website. In May, following requests from industry representatives the Division began publishing details of all current exemptions on our website.

There were 31 exemptions still in operation at the end of the year. It is currently taking approximately 21 weeks for an installer to get licensed following the issue of an exemption.

Instalment Arrangements

In October, the Authority introduced an instalment payment facility for contractors with a turnover of less than €150,000 who were renewing their licence. The facility was introduced following requests from contractors and public representatives for such a service and is for an initial period of 12 months after which time it will be reviewed. 18 contractors availed of the facility in 2010.

Licence Registers

The Authority's website contains registers of all contractor and individual licence holders and are updated on a regular basis. There were 49,569 visits to the registers in 2010 up from 37,167 visits in 2009. The increased volume shows the importance of the registers as a tool for the industry and public. The individual licence holders register received most visits with 20,452 followed by Installer (Intruder Alarm) contractors 8,121. Copies of the contractor register are also available for inspection at Garda Stations in accordance with section 33(7) of the Private Security Services Act.

Judicial Reviews

The Authority was involved in two judicial review cases before the High Court. The first case was lodged by the Authority against a decision of the Appeal Board to grant a licence to a contractor. The Authority had refused the application on the grounds that the contractor did not comply with the requirements of the Private Security Services Act 2004 by virtue of the fact that the contractor had provided security services without a licence (A breach of S37 of the Act). The Appeal Board did not accept that the breach of section 37 constituted a failure to comply with a requirement of the Act and decided that the contractor satisfied all the statutory requirements to obtain a licence. The contractor subsequently went into liquidation and the action lapsed.

The second case was taken by a contractor against the Appeal Board and the Authority is a notice party in the proceedings. The application was refused by the Authority in accordance with section 22(3)(b)(i) of the Act on the grounds that a person connected with the contractor was not a fit and proper person to provide a security service. The Appeal Board upheld the Authority's decision.

Licensing - Individuals

Application Processing

The Authority had another busy year in 2010. There were 25,352 licences in circulation at the 31 December 2010, a fall of 6% on the number of licences at the end of 2009 (26,942).

Individual Licences – First Time Applications

6,171 first time applications were received during the year representing a 5% increase on the 2009 figure of 5,860. These, combined with the 7,544 renewal applications received means the Authority processed 13,715 applications in 2010 and over 51,600 since the licensing of individuals commenced in 2007.

Individual Licences - Renewals

The first individual renewal licences and identity cards issued in January and by the end of the year 10,863 (60%) of the 17,974 licences which had expired had been renewed. The non-renewal rate is higher than had been anticipated and highlights the historic high staff turnover in the industry together with the economic impact of the past two years.

Revocations and Suspensions

The monitoring of licence holders during the term of the licence is an important aspect of licensing. Where the Authority finds that a licence holder has breached the requirements of licensing it can suspend or revoke a licence. In 2010, 4 individuals had their licence suspended for breaches of licensing regulations while 7 licences were revoked due to criminality related issues.

Refusals and Appeals

158 applications were refused compared to 1,714 in 2009 and as with the reduction in applications rejected, the reduction here can be attributed to the steps taken to improve the quality of applications received. There was a marked change in the reason for refusals in 2010. In previous years the main reason for refusing an application was failure to provide a foreign criminal record certificate followed by failure to provide evidence of training. In 2010 the main reason was under Section 22(3)(a)(i) (not a fit and proper person to provide a security service) which accounted for 56% of refusals compared to 9% in 2009. Most of these cases related to criminal convictions or court cases pending.

There were 19 appeals against the Authority's decision to refuse to issue a licence lodged with the Private Security Appeal Board during the year together with 2 appeals against decisions to revoke licences and 2 cases against decisions to suspend licences. A total of 267 appeals have been lodged since licensing commenced and at the end of the year 25 appeals awaited a determination by the Appeal Board.

Individual Licensing – Processing Improvements

A number of significant processing changes have been introduced during 2010 so as to ensure the fastest turnaround for completed applications.

Scanning

The Authority installed a new scanning system in the first quarter of 2010 and made enhancements to the individual database to facilitate the capturing of data from the scanning system. The new system not only allows the Authority scan applications in-house but allows for the scanning and data capture of the bulk of applications to be outsourced. The introduction of the system has removed the need for manual data entry of applications which was resource intensive and has led to a more efficient processing of applications.

The scanning process together with ongoing improvements to our other processing systems led to further improvements in processing times in 2010. At the end of the year the average processing time for first time applications received during the year was 76 days compared to 61 days in 2009 and 168 days in 2008. The average processing times for renewal applications was 14 days bringing the combined average to 46 days.

The processing times of first time applications is greatly influenced by the vetting process. Average vetting times ranged from 43 days to 94 days during the year. The Authority works closely with the Garda Central Vetting Unit to reduce these times and in November funded the recruitment of a temporary staff member in the Vetting Unit to assist with the vetting of applicants.

Rejection of Incomplete Applications

698 individuals had their application rejected on receipt as they failed to include all necessary documentation with their application. This represents 5% of all applications lodged in 2010 down from 15% in 2009 and highlights the success of the measures taken over the past two years to improve the quality of applications received. There were 42 incomplete applications on hands at the 31st December 2010.

Texting Service

At the end of 2009 the Authority introduced a texting service which allowed licence holders request a renewal application pack. This service was extended during 2010 with the Authority contacting licence holders to advise them of the expiry of their licence. 5,012 texts were issued to licence holder during the year while over 2,000 texts were received by the Authority.

Licence and Identity Card Contract

The production of licences and identity cards and their despatch to licence holders is undertaken by an external contractor on behalf of the Authority. In November 2009 the Authority issued a Request For Tenders to provide this service and the closing date for submissions was the 8th January 2010. The tender also included a request to scan application forms for the Authority.

The contract was awarded to Credit Card Systems Ireland and the company started to issue licences and identity cards in June. The scanning of application forms commenced in August.

The new contract has allowed the Authority reduce the cost of licence and card production while at the same time adding new security features to the card.

Late Applications

A major resource issue for the Authority has been the volume of licence holders who renew their licence after the expiry date. This stood at 38% in 2010 and a number of measures will be introduced to try and reduce this to below 30% in 2011.

Duplicate Licences

The Authority issued 407 duplicate licences and identity cards in 2010 bringing to over 1,300 the total number issued since licensing commenced. The Authority does not currently charge for duplicates. However, proposals to introduce a fee in 2011 are currently being considered.

Working while licence application is being processed

In July, new procedures were introduced for first time applicants seeking acknowledgement letters for work purposes. Since then only applicants meeting the following criteria receive an acknowledgement letter;

The applicant works for a licensed contractor and the applicant has declared on the Garda Vetting Form that he has never been convicted of an offence.

or

The applicant works for an employer approved by PSA (large retailers, etc.) and the applicant has declared on the Garda Vetting Form that he has never been convicted of an offence.

or

The applicant has a letter from an employer confirming that he has an offer of employment and the applicant has declared on the Garda Vetting Form that he has never been convicted of an offence.

Where an applicant declares no convictions on the vetting form and the vetting results subsequently show a conviction the application is refused.

Criminality Guidelines

The Authority's *Guidelines on Convictions* which were introduced in 2007 provide guidelines for dealing with cases where a conviction is disclosed as a result of Garda vetting or a foreign criminal record certificate. The guidelines were amended this year to incorporate a section on the Good Friday Agreement and the release of prisoners.

New guidelines based on our experience over the past 3 years will be published in 2011.

Goal 2:

We will drive the transformation of the industry using a framework of standards for private security providers and qualifications for individuals working for such providers.

Overview

Licensing of contractors providing security services requires the contractor applying for a licence to adhere to standards required by the Authority.

In general there are two types of standards:

1. Quality Management Systems standards and
2. Product/Technical standards

The objective of quality management standards is to specify general management standards for security services being provided in terms of the management of the security provider, staff training, recruitment procedures, the supporting documentation and how it is housed and the quality of the service provided to the client. Product or technical standards specify technical or operational requirements for the specific type of security provided.

General

In 2010 the Division sought to improve its service to the public and other stakeholders by providing published information. During the year the Division produced an information leaflet for the public on intruder alarm systems. This leaflet was also reproduced on the website of the Citizens Information Centres by kind permission of that organisation. This information leaflet is available on our website or on request from the office of the Authority.

Standards

1. Sectors for which licensing has commenced

Door Supervisor and Security Guard (Static)

The need to update the standard IS 999:2004 was identified in 2009. In 2010 the PSA continued to consult with industry stakeholders in relation to the development of a revised standard. In that regard both employer and employee representatives submitted proposals in relation to amendments to the existing standard. In addition the PSA itself, through the relevant staff members, proposed changes to the standard which it feels are necessary to improve auditable standards in the sector. Based on the various strands of feedback an advanced draft was prepared in late 2010 and this also is the subject of further ongoing consultation with industry stakeholders before the final stage of development is undertaken in conjunction with the NSAI in 2011.

Installers of Intruder Alarms

Installers of Intruder Alarms are subject to PSA licensing and contractors in this sector must attain compliance with IS EN 50131 (parts 1 and 7) as part of the licensing requirements. During 2010 the PSA considered the issue of applying licensing requirements to those who maintain intruder alarm systems, as provided for under the Private Security Services Act 2004. Issues in relation to determining compliance with prescribed standards remained to be resolved at the outset of the year. In 2010 the PSA, as a result of its consideration of the issue and on foot of extensive consultation with relevant outside stakeholders, proposed a solution to the issue which will, following some minor adjustments and clarification be implemented in 2011. This resolution seeks to ensure that the full range of intruder alarm service providers defined in the Private Security Services Act 2004 as being subject to PSA licensing will now more readily come within the scope of the Authority's licensing. The result is that all service providers providing installation, repair and maintenance of intruder alarm systems should be on the Authority's register of license holders. As with all licensable activities, the provision of a service covered by the PSA's remit without an appropriate licence will result in prosecution and possible criminal conviction.

2. Sectors for which licensing has not yet commenced

CCTV

During 2010 the document setting out the requirements for installers of CCTV systems for security purposes entitled “Requirements for CCTV Installation” was finalised. This will form the basis for licensing of this sector once a critical date has been prescribed by the PSA. This document is available, on request, from the PSA. It is intended that licensing of this sector will commence in the latter half of 2011.

Other Sectors

The remaining sectors to be licensed in further phases of the PSA’s licensing programme do not currently have standards and will require a body of development work to be undertaken in advance of the commencement of licensing. The PSA will continue to examine and evaluate its policies as they relate to conditions attaching to eligibility for PSA licenses. As more activities are brought within licensing, the PSA will, in the context of reduced resources for both ourselves and those we regulate and the need to use our diminished resources more creatively, look at the scope, nature and applicability of the standards that form the foundation of licensing. This will be just one part of the evolving evaluation of our policies and processes throughout the organisation.

In relation to the licensing of event security services, the Authority will commence the licensing of this activity in 2012 however all supporting legislation and documentation will be finalised and in place by the end of 2011. The Authority will publish guidelines in 2011 which provide both guidance and information to contractors and other members of the public in advance of the formal commencement of licensing of this activity.

Better Regulation

The PSA has, over the years, sought out the opinions of our stakeholders, licensees and future licensees on what issues concern them and how the Authority can reasonably help to address those concerns. While it is difficult to envisage a system where regulation results in the complete absence of additional costs, the Authority is sensitive to the current economic climate and will, in 2011, endeavour to begin to introduce structures that minimise costs for stakeholders. In that respect, it will examine costs associated with compliance. A significant amount of preparatory work was carried out in 2010 and many options, particularly in relation to structures around

compliance certification, were developed, analysed and evaluated. The Authority has a vision, in principle, what should form the foundation of any new certification system and has consulted over the last year with various interested parties on this. 2011 will see this preparatory work and consultation come to fruition with the fleshing out of the detail around that new structure. This is a big step in the evolution of the operation of the Authority and is driven by the needs of the industry as well as the need for a more effective and bespoke system of certification that maintains and improves standards within the industry.

Training

The Authority has continued its day-to-day training related activities in 2010 as well as undertaking some important background research, both national and international, which informs the decision making of the Board and the Executive. The Authority is the designated Competent Authority for the evaluation of equivalence of non Irish qualifications in respect of activities which it regulates.

Mutual Recognition of Foreign Qualifications

Under the Mutual Recognition of Qualifications Directive (Directive 2005/36/EC of the European Parliament on the Recognition of Professional Qualifications, as amended by Directive 2006/100/EC,) which was incorporated into Irish law, Ireland, along with other EU Member States, cannot discriminate unfairly against EU citizens wishing to pursue an occupation or profession for which they have qualified in another EU Member State.

The PSA will, as the Competent Authority, consider all qualifications obtained outside the jurisdiction, where an applicant falls within the scope of the EU Directive, and determine whether or not these qualifications are acceptable as meeting the training requirements for licensing. Where there is a deficit in the learning outcomes of the qualification obtained in another Member State to an extent that it would impact on the person's ability to perform the duties, the PSA, as competent authority will, where the deficit is of a significant or essential nature, require the holder of the foreign qualification to undergo an assessment or a period of adaptation until the deficit has been shown to be addressed. This system also applies to holders of Irish qualifications who wish to pursue their chosen occupation or profession abroad. As more sectors become subject to

licensing in 2010 and beyond, the range of qualifications which the PSA will consider under the Directive, will grow.

The table below shows the number of applications received from persons holding qualifications awarded by a body outside Ireland.

Guidelines for Students Undertaking Work Experience/Practice in a Regulated Activity

The Division, in response to queries from stakeholders, published guidelines on our website in relation to the PSA requirements concerning work placement or work experience for students undertaking courses of study in security related fields. These were published to provide clarity for students, employers and training providers regarding licensing requirements in such cases. The guidelines set out the conditions under which work placement or experience can be undertaken without the legal requirement to hold a relevant PSA licence.

Standard Development Group

In 2010 the PSA was a significant participant in the Standards Development Group, which is chaired by FETAC and whose aim is to consolidate existing security courses and to develop new courses and programmes where none have existed up to now. The PSA contributed to the first phase of the project which involved the migration of existing Major Awards to a more consolidated and updated basis.

Goal 3:

We will monitor and control the transformation of the industry through investigation, enforcement, prosecution and a system of quality control.

The Authority was very active in 2010 in fulfilling its enforcement role and using its powers against those in breach of the Private Security Services Act 2004. Enforcement operations targeted individuals, contractors and clients and the breaches involved;

- those contractors and individuals providing unlicensed security services;
- those employing unlicensed security providers including individuals;
- those who are licensed to ensure that licensees are operating within the remit of their licence and are adhering to the appropriate standards.
- those not complying with the ID Badge requirements

As part of this work the Authority carried out inspections on 850 licensed and retail premises to check contractor and individual compliance including ID badge compliance.

Intelligence

Intelligence from the industry continues to be a key aid to the Authority in targeting its inspection resources. The receipt of detailed and specific intelligence is vital in assisting the investigative work of the Authority. Of the 606 pieces of intelligence received across all sectors, 423 have led to enforcement cases being created or linked to existing cases, and being investigated. 183 pieces of intelligence are not being investigated as the information received was insufficient or that the contractor was licensed and that was the basis of the information. The Alarm Installer sector created the largest volume of intelligence at 221 followed by the Door Supervisor sector at 180 and Security Guarding at 169. The 606 intelligence reports received during 2010 is a reduction on the 811 received in 2009, and in both years the alarm installer sector continues to create the highest number of reports.

The Authority assessed all information and intelligence submitted to it from various sources from within and outside the industry. It also carried out its own internal assessment of particular cases, issues and sectors. The outcome of those assessments drove some of the operational work of the division during 2010. The reporting of unlicensed security providers and the reporting of breaches of the conditions of licensing continues to be an invaluable tool in targeting those who are operating illegally or outside the terms of their licence.

The following is a sample of the type of cases encountered by the Authority during the year:

Security Guard (Static) Licensed Contractor - Ensure employees are licensed

- Case created in October 2010.
- At the start of this exercise the contractors employee licence compliance was at approx. 94%.
- A number of meetings were held between the Directors of this company and the regional inspector.
- Compliance notifications were issued to this contractor over a period.
- The goal of 100% compliance has now been achieved with entire licensable workforce, over 1,500 individuals, now fully licensed.

² Not being investigated means that the intelligence supplied was insufficient or that the contractor is licensed and that was the basis of the intelligence supplied.

Prosecution of Unlicensed Security Guard (Static) Contractor

- Case created based on intelligence received in April 2010 alleging provision of security guard (static) services by an unlicensed contractor.
- Site visit to client confirmed unlicensed provision of security guard (static) services and contact details of the unlicensed contractor.
- Invoices supplied by the unlicensed contractor and corresponding remittance notes obtained from the client.
- Case submitted to PSA Solicitors in July 2010.
- Unlicensed security guard (static) contractor successfully prosecuted in November 2010 fines of €37,500 imposed.

Suspension of Individual Door Supervisor (Licensed Premises) License

- PSA Inspector formally notified by An Garda Síochána that an individual door supervisor (licensed premises) license holder had been charged with various offences including violent disorder and criminal damage.
- On foot of information received a recommendation was submitted by Enforcement Division to Licensing Division that the individual door supervisor (licensed premises) license holder have their license suspended '*on reasonable grounds that the safety or welfare of any person or persons is or may be at risk from the continuance in force of the license*'.
- The individual license was suspended immediately.
- An Garda Síochána requested to confirm that the individual is not currently providing door supervisor (licensed premises) services at their last known place of employment.
- Confirmation received from An Garda Síochána.

Security Guarding Contractor (Unlicensed)

Investigation of an unlicensed contractor began when it transpired that the contracts of a previously licensed contractor were transferred to the unlicensed contractor following a liquidation of the former and the refusal of their renewal licence application.

- Formal contact made with the appointed Liquidator to obtain client details.
- Formal contact made with 44 known clients of the Liquidated entity.
- Formal enforcement of a number of clients.

- Gathering of evidence from clients to build a prosecution of their new (unlicensed) security provider.

Security Guarding Contractor (Unlicensed)

Investigation of an unlicensed contractor who passed off a licence record contained on the Register of Licence Holders as his own licence in order to obtain work as a security Guarding contractor.

- Formal contact made with a property management company that hired the unlicensed security contractor in order to ascertain their understanding of the security entities licence status and to obtain evidence of any licence or licence type document that may have been used as a licence record by the security contractor.
- Formal enforcement with property management company regarding employing an unlicensed security contractor.
- Formal gathering of evidence from client to prove that services were provided and paid for in order to facilitate a prosecution of the unlicensed security contractor.

Security Guarding Contractor – Non Renewal (Unlicensed)

Investigation of an unlicensed security contractor initiated when it was found that the contractor who did not renew his contractor licence had falsified his licence by changing the expiry date by one year to give the impression that a licence was current in order to obtain work as a security guarding contractor.

- Formal contact made with the known client in order to obtain details of the security guarding services provided.
- Follow up contact with the client to advise them of their obligations and to obtain evidence of the unlicensed security provision.
- Evidence (including the falsified licence) submitted to the Gardaí for consideration of criminal proceedings.
- File submitted to legal advisors for prosecution case.

Employment of unlicensed Door Supervisor (Licensed Premises) personnel on an in-house basis

Investigation of 3 individuals employed as door supervisors who were not licensed began when it was found that they were long term employees of a night club owner.

- Formal contact made with the night club owner to obtain the full employment history of the 3 individuals.
- Formal Enforcement of the employer followed.
- Formal request for documentary evidence of services provided and remunerated.
- Files prepared in each individual case for a prosecution on foot of evidence obtained, cases submitted to legal advisors.

Prosecution of Unlicensed Installer (Intruder Alarms) Contractor

- Case created February 2010 following allegations by source that unlicensed contractor active in a particular area, and that the contractor would be actively engaged in an installation on a particular date.
- Site inspected on this date, unlicensed contractor found to be actively engaged in installation. Interviewed under caution.
- Opportunity availed of to interview householders in the area regarding installations by same unlicensed contractor.
- Evidence from two subsequent investigations, and evidence obtained in a third case in a different region submitted for prosecution.
- Contractor convicted in December 2010.

Unlicensed Installer (Intruder Alarms) Contractor intercepted while on site

- Information received November 2010 that known unlicensed contractor currently present on building site.
- Site visited within one hour of receipt of information.
- Builder and unlicensed contractor interviewed at length.
- Not possible to establish that breach had taken place as inspection effectively prevented the breach from being committed.
- Both parties informed of licensing requirements.

- Subsequent investigation of builder, found that services of unlicensed contractor terminated immediately and that licensed contractor now engaged.
- Position confirmed independently with licensed contractor.
- Valuable information obtained from inspection from which further investigation of unlicensed contractor has stemmed.

Complainant found to be themselves in breach of legislation

- A contractor licence holder who was a regular complainant to the PSA alleged widespread unlicensed activity in a particular region.
- Each complaint received was investigated whereupon no evidence of the extent of such activity was found.
- One specific complaint alleged the engagement of unlicensed personnel at a particular location.
- PSA interacted with the owner of the location fully informing them of obligations regarding employment of unlicensed providers.
- A compliance inspection was subsequently conducted in the area which showed high levels of compliance, further refuting the earlier allegations.
- The only individual found to be unlicensed was employed by the original complainant at the site complained about.
- Correspondence issued to the contractor outlining employment of unlicensed employee.

Case Management

All live cases that have been open for more than three months are actively reviewed. The following chart sets out the position regarding the aging of all live cases as at 31st December 2010:

While only 8 of the live cases are more than 12 months old, the PSA will not close a case until it is satisfied that all reasonable steps have been taken to investigate and resolve the issues.

Contractor Compliance – PSA Monitoring

The enforcement role in relation to monitoring licensed contractors continued to be an important focus during 2010. Inspections were carried out on 101 licensees to ensure that they were operating within the remit of the licence granted to them and that they met the conditions of the standard and other requirements set out for that licence. A number of serious breaches were found which led to actions being taken against licensees.


Reprimands, warnings, cautions and advices were issued against licensees. This process demands that corrective action is taken. The main issues found related to tax compliance, pay rates, staff screening, training and employing unlicensed staff. The follow up by the Inspectors ensures that all contractors are operating to the same terms and that the client and public are safeguarded in that the service is being delivered to a high standard by those who are Garda vetted and trained.

The following were the outcomes of the Contractor Inspections:

- Twenty one (21%) contractors were found to be compliant.
- Thirty seven (37%) contractors were found to have at least one major category 1 non conformity.
- Sixteen (16%) contractors were found to have category 2 non conformities.
- Twenty seven (27%) contractors were found to have category 3 non conformities.
- Four of the inspections related to pre licensing, in three cases the licence was recommended following resolution of the issues found and in one case a recommendation was made to refuse the licence.

Security Guarding and Door Security Compliance

The chart below and the findings of the inspections listed above outlines the incidents of non compliance by category of non compliance, by sector and size of contractor. When the compliant contractors and those with category 3 non compliances (relatively minor) are put together, it accounts for almost half (48%) of those inspected.



The main issues of non compliance arose with small contractors in the SG and DSP sectors with less than 50 employees where 37% of contractors of this size showed at least one major non conformity i.e. an issue that would have prevented the contractor getting an IS999 Certificate and becoming licensed. Where the Contractor is DSP only, there are less issues of non conformity as a large proportion of individuals working in this sector are in-house and therefore there is less movement of contractors etc. Also normally staff are paid well above the required rates, this is because of the nature and hours of work.

Inspections on Contractor licensees will continue in 2011 with the PSA moving to more formal risk based operations over the coming year.

Door Supervisor Compliance

In the Door Supervisor sector 12 clients terminated the contract of unlicensed contractors and 21 contractors are no longer operating. In 42 cases, post inspection/investigation issues have been resolved. The comparative figures in 2009 were: 27 clients terminated contracts, 62 no longer operating and 26 cases where post inspection/investigation issues were resolved.

Security Guarding Compliance

In the Security Guarding sector there are 88 live cases with 53 of these cases involving contractors. Of the live cases 8 were opened in 2009, and there are ongoing issues in relation to each of these cases. All other live cases were initiated since 01 Jan 2010. In the Security Guarding sector 46 clients terminated the contract of unlicensed operators and 51 contractors are no longer operating. In 34 cases, post inspection/investigation issues have been resolved. The comparative figures for 2009 were: 35 terminated contracts, 55 no longer operating and 38 post inspection issues resolved.

Intruder Alarm compliance

The Intruder Alarm sector continued to be a priority focus of enforcement activity during 2010. Of the 402 cases, the Installer (Intruder Alarm) sector has the highest number of cases at 171 of which there are 111 client cases under investigation and 60 contractor cases. The target was both the unlicensed operator and their clients. Intelligence was the key tool in driving investigations and those who did not renew their licence were also targeted. Four successful prosecutions were achieved against those operating illegally in this sector. The PSA also wrote to all the monitoring

centres seeking details of connections. These details were cross checked against the licensing database and any unlicensed activity was investigated. Information was also sought from all alarm system manufacturers in relation to those they supply and those to whom they provide training. This process will be repeated again in early 2010.

In the Alarm Installer sector it was found that in 62 of the cases the contractor was no longer operating and that in 36 of the cases the contractor was licensed. In 172 cases the information was insufficient to warrant further investigation. The comparative figures in 2009 were: 129 no longer operating, 94 where the contractor was licensed and 185 where the information was insufficient.

Alarm Monitoring Centres

In the first quarter of the year the PSA conducted an exercise with all monitoring centres in relation to new alarm connections referred to them during 2009. The list of intruder alarm contractors submitted by the monitoring centres was cross checked against the licence register. Feed back was given to the monitoring centres and appropriate action taken against unlicensed contractors.

In addition, inspections were carried out on a small number of alarm monitoring centres which resulted in a reprimand and an advice being issued.

Cash in Transit

The Inspection team aided by International consultants finalised its assessment work in relation to the CIT sector. As a result of the substantial work carried out, the PSA issued licenses to CIT contractors. The PSA continues its interaction with the CIT sector in relation to the technical and other requirements and will be monitoring the operations of the licensees during 2011.

Action Against Contractor Licences

During 2010, as a result of the inspections on licensed contractors and other enforcement work the Authority initiated the following Section 26 actions against contractor licensees;

- 1 Revocation
- 2 Suspension
- 7 Refusals
- 2 Reprimands
- 32 Warnings
- 12 Cautions
- 27 Advices
- 5 Licence issued with Reprimand

(These figures will vary from those reported in the outcome confirmed report as some of the above cases remain open and some of the outcome confirmed cases commenced in 2009)

The PSA will continue to issue such actions in 2011 where appropriate.

Of the cases which were closed in 2010, there were 57 contractor cases where post inspections issues were resolved and Section 26 was invoked.

Individual Compliance

During 2010, the PSA Inspectors targeted individual licensing and compliance with the requirement to wear ID badges through inspections on licensed premises and venues where door supervision and security guarding is carried out. On occasions they were accompanied by members of the Gardaí. Inspections were carried out at night, during the day and at weekends on 850 premises around the country. This was an increase from 679 premises visited in 2009. For those venues with security: 320 engaged security contractors showing almost a 100% compliance rate with contractor licensing. Overall individual licensing for both sectors showed a 91% rate of compliance. The compliance rate is on a par of that found in 2009, however over 170 more premises were visited during 2010.

Since the introduction of the ID Badge regulations on 1 September 2009 the PSA has been checking compliance with the requirement. It has issued Warning letters to those individuals found not wearing the ID Badge. The PSA has also commenced suspending the licenses of those found in breach of the ID badge requirement on a second occasion. During 2010 the compliance rate in relation to the wearing of the ID badge was found to be relatively high in the Security guarding sector at 89% whereas in the Door Supervisor sector it is 69%.

Compliance by individuals in relation to being licensed and the requirement to carry the licence was found to be 95% in the SG sector and 85% in the DSP sector.

During 2010 the following actions under Section 26 of the Act were initiated against licensed individuals:

- 5 Refusals (recommended to Licensing Division)
- 3 Suspensions (recommended to Licensing Division)
- 237 Warnings
- 39 Cautions
- 28 Advices

The majority of those actions were taken as a result of breaches of ID Badge requirement. The PSA will continue to enforce in relation to individual licensing and the ID Badge requirement into 2011.

There were 314 cases relating to Individual Licensees closed during 2010 where Section 26 had been invoked.

The actual numbers for Section 26 notices issued from Enforcement Division to individuals during 2010 are as follows:

During 2010 the number of Section 26 actions against individual licensees has increased substantially, mainly due to the ID Badge requirements being vigorously enforced by PSA inspectorate.

Action against Clients

The targeting of clients is a very important aspect of the enforcement work. The power to prosecute a client of an unlicensed security service provider has been one of the most effective tools in ensuring compliance with licensing requirements. There were a number of significant cases which demanded detailed investigative work on the contractor and its clients. In a number of cases each client was tracked to ensure that the client terminated the contract and moved the contract to a licensed contractor or in some cases the client took the security staff in house.

Formal complaints against licensees

There was a substantial increase in the number of formal complaints against licensees in 2010, most of which were against individuals. Enforcement Division received 28 formal complaints, all of which were dealt with under Section 39 of the Private Security Services Act, 2004 and in accordance with the Private Security (Complaints Procedures) Regulations 2006. The number of cases finalised was 15 and the outcomes include: in 3 cases where no action was taken against the licensee; 12 cases did not proceed to a full investigation as the complainants did not wish to proceed further with the complaint.

Prosecutions

The Authority brought 8 cases to Court in 2010 and had 7 successful prosecutions. Other cases submitted in 2010 are awaiting legal advice and/or Court Hearing. Four cases have already been

listed for Court Hearing in January and February 2011. The Authority is preparing a number of other cases for prosecution which will come before the Courts during 2011.

In 2010, Fines totalling €58,500 and Costs of €23,672 were awarded in prosecution cases brought by the Authority.

Private Security Authorities Liaison with other State Agencies

Enforcement Division has built a structure for liaison and consultation on issues with other State agencies in order to fulfil our mutual responsibilities. Work has been carried out in conjunction with and with the assistance of the Gardaí, Revenue Commissioners and the National Employment Rights Authority (NERA).

Liaison with the Gardaí has taken place on a number of levels. In relation to the licensing of the CIT sector the Gardaí offered advice in relation to specific issues. In relation to the DSP and SG sectors, they provided assistance with particular cases and on occasions accompanied the PSA Inspectors during night inspections.

During 2010, Enforcement Division has used the Memorandum of Understanding which has been put in place with the Revenue Commissioners to obtain information in relation to tax compliance of contractors. The PSA has requested information in 88 cases compared with 79 cases in 2009 and has supplied information on request by the Revenue Commissioners in 22 cases, down slightly on the 28 requests received from Revenue in 2009. This exchange of information has been a useful tool in making a full assessment of particular cases. Liaison with NERA continues on general issues.

Also during 2010, the PSA established a formal channel for accessing Land Registry details, and can now view details through the online service of the Property Registration Authority.

In March, the Licensing Division received a request from the Department of Social and Family Affairs for details of all individuals who were licensed. As an authorised user of the PPS Number the Authority is obliged to provide this information to the Department. The Department previously received this information back in 2008 when 1,680 licence holders were identified as claiming social welfare payments and savings in excess of over €1 million were made by the Department. Results from the 2010 list are expected during 2011.

Goal 4:

We will develop an efficient and innovative organisation with motivated and skilled staff supported by appropriate physical infrastructure and facilities.

Financial Planning

In line with Government policy the Authority is continuously striving to be self-financing despite the difficult economic climate. The high rate of individual applications together with a renewal rate of 60% for individuals has resulted in licence fee exceeding the PSA 2010 expenditure allocation. Income for 2010 is boosted as the majority of our contractor licences were due for renewal during the year. While the licence is for two years, under our existing accounting rules, all fee income is apportioned to the current year. Looking to the future it is unlikely that the excess of income will be maintained given the pressure on the industry from the wider economic difficulties.

By stringently monitoring our expenditure and we have come in within our current very tight budget allocation. The Authority actively pursues policies and implements procedures to ensure that the most cost efficient and economically advantageous structures are adhered to at all times.

Communications

Media

Our focus for 2010, as was similar to 2009, saw most of our communications being generated by articles on the National newspapers, trade magazines and electronic newsletter. In particular we ensured that provincial media were informed of our enforcement activities relating to their specific areas of the country. This has proved to be a useful tool in furthering the promotion of the work carried out by the Private Security Authority. It also resulted in a radio interview which was dealt with by the Chief Executive.

Telephones

Over the past two years the Authority has worked hard to improve the telephone service and the difficulties experienced in 2008 have now largely been eliminated. There continue to be some problems at certain peak periods during the year and further improvements to the telephone service are currently being investigated.

Email

A central part of this work is the use of email as the preferred means of communication. This is a more efficient way of dealing with queries as they can be made at any time and staff can respond during quieter periods in the day. In practical terms the Contractor Licensing Unit issued 2,356 items of post during 2010 and received over 4,000 postal items, phone calls and emails during the year. The individual licensing unit despatched 29,284 items of post to licence applicants in 2010. Reducing these costs will enable us to target resources to those who have a specific query and need assistance from our staff.

Scanning

The scanning system which was introduced earlier in the year further supports this work by capturing email addresses from individual application forms. Licensing Division commenced contacting applicants and licence holders in December and 2011 will see increased usage of email as we aim to reduce our postage volumes. The dedicated email address *licensing@psa.gov.ie* remains a popular means of contact for contractors and individuals with licensing queries and received over 5,100 messages during 2010.

Post

Considerable progress has already been achieved in reducing our postal costs. The drop in post is due to the increased use of alternative communication channels and the more efficient processing of applications which reduces the need to contact applicants. This drop is illustrated in the table below.

Website

Our website is a popular and effective means of communication for all our customers keeping them up to date with current information and publications. All application forms are available for download giving licensees immediate access to information.

Registers of licensees are also available on-line. The licensing tab on our website holds the latest licensing information and the page received 4,837 visits while over 5,000 application forms were downloaded from the website. The register of individual licence holders was the most popular page on the website with over 20,450 visits. In addition to the visits to the Registers, there were 673 contractor packs downloaded from the site and 871 visits to the list of exemptions to install intruder alarms.

Ezine

In 2010 we issued 5 newsletters to all our contractor licensees along with a number of interested parties. It is a simple and cost efficient means of communicating with all our stakeholders on all the workings of the Authority including developments in training and standards, licensing issues, enforcement activities and statistics and other relevant information. We are looking to expand the use of the ezine in the future when it is hoped a specific newsletter may be issued to all licensed individuals on our database.

Text messaging

The use of text messaging is a very important communication tool. It gives instant access to all individuals on our database and is proving to be very popular. In 2010 the licensing Division sent messages to those already licensed informing them that their license was due to expire and if they wished to renew their licence to request an application form by text using their mobile.

Staffing

The Authority is structured around three key operational divisions with responsibility for licensing, enforcement and the development of training and standards. In addition there is a small support unit which handles financial matters, media relations and general corporate matters. An organisation chart is at Appendix 1.

Our staff continue to be our greatest asset and we will be supportive of their efforts as they work through difficult times for the benefit of all our customers and the public at large. Congratulations to two staff members who successfully completed a Diploma course in Justice studies with the IPA .

Goal 5:

We will actively participate and pursue our role in the EU and at wider international level, working with other EU and International Private Security Regulators, to contribute to the formulation of policy in this area.

The experiences of other regulators are a key resource for the PSA in developing future policies and operational practices. On an ongoing basis, the Training and Standards division monitors developments with other European regulators, focusing in particular on those that are standards driven. It is our intention over time to build a comprehensive repository of this information.

A key method of maintaining such information is through ongoing contact between EU regulators. The Chief Executive lead an initial meeting of some private security regulators interested in sharing regulatory experiences. Information was exchanged on the method of regulation, the different standards required for licensing and the experiences of taking action against security providers who breach such regulations. The meeting also considered the experiences of regulators where the private security industry had engaged in the provision of security through public private partnerships. It is hoped to have further exchanges of the group although resourcing the exchange in the current economic climate is challenging for all EU regulators.

The Private Security Authority also had observer status on the Northern Ireland/UK/Security Industry Authority implementation board during the policy formulation for the implementation of licensing in Northern Ireland. Licensing based on the UK system was introduced in Northern Ireland for all sectors except door supervisor with effect from 1 December 2009. It was introduced for door supervisors with effect from 1 April 2010.

On a broad basis the Authority contribute to the formulation of EU policy through contributions provided to the Department of Justice and Law Reform. In 2010 this liaison focused on discussion on the cross-border transportation of Euro cash by road. The main issue for the Authority was to ensure that any proposals did not undermine the requirements for PSA Cash in Transit licensing.


STATEMENT OF AUTHORITY MEMBERS' RESPONSIBILITIES

STATEMENT ON INTERNAL FINANCIAL CONTROL

On behalf of the Private Security Authority, we hereby acknowledge our responsibility for ensuring that an appropriate system of internal financial control is in operation in the Authority.

We are satisfied that the systems, which the Authority has in place, are reasonable and appropriate for the Authority's circumstances having regard to its size, level of expenditure, staff resources and the nature of its operations. However, the systems do not, and cannot, provide absolute assurance against material error.

Following the publication of the Department of Finance new guidelines for Corporate Governance the Authority is preparing a new code of governance to reflect these requirements. The Authority currently uses the IPA published guide for Board members of State Bodies in Ireland for briefing its Board members on their role as a member of the board of a state body.

The Board of the Authority receives the Chief Executive Officer's report, which gives a detailed account of expenditure recorded on a monthly basis together with income. This is reviewed by the Board at every meeting.

The Authority takes the major strategic decisions and meets at regular intervals to monitor performance and plans. The executive management only act within the authority delegated to them by the Authority to give effect to the Authority's policy and decisions.

STATEMENT ON INTERNAL FINANCIAL CONTROL

A detailed procedural manual has been prepared and put in place. Income is subject to overall reconciliation and where possible, staff duties are appropriately divided taking account of the risks involved and the limited number of staff. The following specific procedures are in place in order to provide effective financial control.

1. Formal procedures are in place for the purchase of all goods and services, for approval of invoices in respect of goods and services and authorisation of payment in respect of goods and services. Procedures in this regard have been strengthened from time to time and recommendations emerging from internal audits have been implemented.
2. Monthly accounts and budgets are prepared throughout the year. At each Board meeting, management accounts are reviewed by the Board of the Authority. The Authority operates a computerised accounting system, which is capable of providing a wide range of financial and accounting information.
3. Budgets are prepared in respect of each year and monthly statements of income and expenditure are prepared to facilitate comparison with budgeted figures.
4. The Authority's financial control procedures are subject to review by the Department of Justice and Law Reform internal audit division. The Department of Justice and Law Reform internal audit division completed an audit of the PSA in 2010 which provided positive assurance to the Accounting Officer and to the PSA as to the adequacy and effectiveness of the overall system of internal financial controls in place.
5. The risk management strategy has been implemented and monitored through a Risk Management Register. The Register is reviewed as a standing item at all Board meetings.
6. The Authority has an Audit Committee which reviews the work of internal audit and the management letter from the Comptroller and Auditor General and management response. It meets the Office of the Comptroller and Auditor General (in the absence of management, where necessary) to discuss the outcome of the external audit.



7. PENSIONS

All of the Authority's staff have been seconded to it from the Department of Justice and Law Reform. Pension liabilities of such staff will be met out of Superannuation Vote 7 and no provision has been made in these Financial Statements in respect of these costs.

8. PRIVATE SECURITY APPEAL BOARD

The Private Security Appeal Board was set up to hear and determine appeals against decisions by the Authority. The Appeal Board is made up of three members and a Chairperson. The Appeal Board is appointed by the Government and is independent of the Authority. The costs incurred by the Board are met by the Department of Justice and Law Reform and are not reflected in the Authority's Financial Statements.

9. PENSION LEVY

Salary costs included in this Account are the gross costs to the Authority for the period. The Department of Justice and Law Reform pays salaries on behalf of the Authority. Pension Levy deductions, as per Section 2(3) of the Financial Emergency Measures in the Public Interest Act 2009 (No. 5 of 2009), are made by the Department and are retained as Appropriations-in-Aid for that Department. This amounted to €90,748 in 2010 (2009: €51,941).

10. AUTHORITY MEMBERS' INTERESTS

The Authority adopted procedures in accordance with guidelines issued by the Department of Finance in relation to the disclosure of interests by members and those procedures were adhered to in the year. There were no transactions in the year in relation to the Authority's activities in which members had any beneficial interest.

11. ACCOMMODATION NOTE

The Authority operates from accommodation at Davis Street, Tipperary Town which is provided free of charge by the Office of Public Works.

12. CHIEF EXECUTIVE REMUNERATION

The Chief Executive's Remuneration for 2010 was made up of an annual basic salary of €114,098 (2009: €123,536). In addition the Chief Executive received €10,924 in respect of Travel and Subsistence expenses in 2010. All expenses are vouched in accordance with Civil Service Travel and Subsistence rates. Pension entitlements do not extend beyond the standard entitlements in the public sector defined benefit superannuation scheme. No performance related payments were made in 2010.

13. DIRECTORS FEES

Fees of €58,140 were paid to Board Members in respect of 2010. Travel and Subsistence expenses of €3,799 were paid to Board Members in respect of 2010.

14. APPROVAL OF FINANCIAL STATEMENTS

These accounts were approved by the Authority on *21 November 2011*.



APPENDIX 4

Energy Report

Overview of Energy Usage in 2010

In 2010 the sources of the main usage of energy in the PSA were heating oil and electricity for lighting and other uses. The PSA moved into its current building in 2008 and the building in Davis Street, Tipperary has been designed with energy efficiency in mind. Light bulbs used are energy-saving bulbs and a modern efficient Building Management System (BMS) was constructed and installed prior to the PSA populating the building. This is evidenced by the C2 Energy rating which is above average for typical buildings of this type.

The PSA appointed an Energy Team in 2010 to provide energy savings as part of the “Optimising Power @ Work” initiative driven by the OPW in conjunction with Vector-FM.

In 2010 the PSA used 105 kWh/m² in respect of electricity and 104 kWh/m² in respect of fossil fuels. The PSA does not have the facility to avail of renewable fuels.

Actions Undertaken in 2010

As stated above, in 2010 the PSA appointed an Energy Team to provide energy savings as part of the “Optimising Power @ Work” initiative driven by the OPW in conjunction with Vector-FM. This team consists of the Energy Officer plus three other members of staff. The team first met in mid-2010 and undertook a number of initiatives to involve staff in saving energy throughout the building.

As the Energy Team was appointed in the latter half of 2010 it is difficult to see immediately the results of these initiatives, particularly as the winter of 2010/2011 was so severe. However the aim of the PSA is to reduce usage by double figures in percentage terms. This will be quite a challenge in light of the good energy rating and the energy-saving materials already used within the building.

In 2010 the Private Security Authority undertook a range of initiatives to improve our energy performance including:

- A poster campaign to alert staff to the energy benefits of switching off electrical appliances and equipment when not in use.
- Twice monthly meetings of the Energy Team to review progress and consider new approaches and initiatives.
- More proactive manipulation of the BMS to achieve efficiencies in energy usage.

Actions Planned for 2011

In 2011 the Private Security Authority intends to further improve our energy performance by undertaking the following initiatives:

- A comprehensive room-by-room, floor-by-floor survey of energy efficiency opportunities.
- A continuing and ongoing examination of building-wide initiatives to improve energy usage.
- Ongoing staff information campaigns to raise awareness of the benefits of becoming more energy efficient.

Is deas liom Tuarascáil 2010 an Údaráis Slándála Príobháidí a chur i láthair. Blilain eile rathúil a bhí in 2010 don PSA ar fud na limistéar uile oibriúcháin dá gcuid.

In ainneoin deacrachtaí geilleagracha ar fud an tionscail, fuair an PSA an lín ab airde d'íarratais aonair ó bhí 2007 ann, an tráth a cuireadh túis le ceadúnú i dtosach. Rinneadh athdhearradh suntasach ar ár bpróiseáil ó shin i leith agus is féidir leis an PSA anois ceadúnais a eisiúint níos tapúla agus i bhfad níos lú acmhainní ag teastál ná mar a sannadh don PSA i dtús báire.

B'ann do mhéadú suntasach ar rátaí comhlíonta acu siúd a oibríonn sa tionscal nuair a seoaldh cártaí aitheantaí anuraídhe mar aon lenár n-imscrúduithe leanúnacha ar an láthair. Is ionann comhlíonadh ceadúnú aonair agus 95% le haghaidh gardáil slándála agus 85% le haghaidh slándáil dorais. Tá sé seo i gcomparáid leis na figiúirí 92% agus 82%, faoi seach, ag deireadh 2009. Tugadh Cáipéis Cheanglas le haghaidh Suiteáil CCTV chun críche ina dtugtar treoir do cheadúnú suiteálaithe CCTV.

Ba bliain dheacair 2010, i gcomhthráth, don PSA agus don tionscal araon. Amhail a tuairiscíodh anuraídhe, is deacair go fóill na coinníollacha trádála le haghaidh an uile ghnóthais sa tionscal le brú leanúnach ar phraghsáil. I gcás an PSA, chuir acmhainní teoranta moill ar thabhairt isteach suiteálaithe CCTV agus foirne a oibríonn le haghaidh cuideachtaí Airgid faoi Bhealach go dtí 2011. Ba chinneadh dian seo ach glacadh é d'fhonn ár gcroícheadúnú reatha a chosaint agus lena chinntíú go raibh againn cumas leordhóthanach le monatóireacht a dhéanamh ar chomhlíonadh caighdeán i limistéir a bhí ceadúnaithe cheana féin.

Bunaithe ar mholtaí an PSA, chuimsigh an tAire líon leasuithe le hoibríochtaí an PSA a fheabhsú i mbille Forálacha Ilghnéitheacha 2010. Tabharfaidh an Bille seo, nuair a achtófar é, don PSA níos mó solúbthachta in úsáid acmhainní. Ina theannta sin, éascóidh sé tabhairt chun críche shainchúram reachtúil an PSA trí rialú limistéir eile an tionscail.

Bhí an tabhairt chun críche seo de cheadúnú ina príomhghhné a chur tiomáint faoi athbhreithniú ar an gcéad ráiteas straitéise den Údarás agus faoi réiteach straitéise nua le haghaidh na tréimhse 2011 go dtí 2013. Cuirfidh an straitéis nua seo leis an seanrath agus caighdeán a ardú níos mó sa tionscal sna blianta amach romhainn ar mhaithe le claint an tionscail agus leis an bpobal mór araon.

Tugann caighdeán fheabhsaithe an tsoláthair sheirbhíse an deis, amhail a tharla go hidirnáisiúnta, don tionscal slándála príobháidí glacadh le breis freagrachtaí lasmuigh den sainchúram traidisiúnta slándála. Le linn trátha ina bhfuil buiséid laghdaitheacha san uile earnáil, d'fhéadfadh an tionscal, ag oibriú de réir na gcaighdeán is airde, réiteach éifeachtach ó thaobh costais de a thairiscint i limistéir, gníomh a rachadh i ngleic le riachtanais na hearnála poiblí agus príobháidí araon le haghaidh soláthar méadaithe slándála agus sábháilteachta.

Lean an tÚdarás ag baint tairbhe as cúnamh comhgleacaithe eile reachtúla, go háirithe an Garda Síochána agus na Coimisinéiri loncaim. Leanann na comhoibrithe seo ar aghaidh agus feidhm lárnach á himirt acu inár bhfeidhmeanna laethúla monatóireachta agus forfheidhmithe.

Ba mhaith liom, arís eile, an méid mór a chur an Bord agus ár bhFoireann Fheidhmeannach, faoi stíúir ár CEO, Geraldine Larkin, leis an méid a bhain an PSA amach le linn 2010 a aithint.

Is deas liom Tuarascáil Bhliantúil 2010 an Údaráis Slándála Príobháidí a chur i láthair. Ba bhliain eile ghnóthach a bhí in 2010 don Údarás agus iarratais mhéadaithe aonair á mbainistiú acu, mar aon le líon ar a raibh borradh ag teacht d'ionchúisimh agus ag oibriú faoi bhrúnna leanúnacha buiséadacha i gcomhthráth.

Fuair an PSA, in 2010, breis agus 13,000 iarratas aonair – 6,171 iarratas nua agus 7,544 athnuachan. Léiríonn an ráta athnuachana seo 60% de na ceadúnais bhunúla le linn chéad bhabhta an cheadúnaithe in 2008. I gcodarsnacht leis an gcéad bhabhta de cheadúnú, níl go leor díobh siúd a chuireann isteach ar cheadúnais den chéad uair ag oibriú go fóill sa tionscal. Léirítear seo trí láimhdeachas a laghdú laistigh den tionscal mar aon le laghdú 10% lena mbaineann ar sholáthar foirne laistigh de chonraitheoirí ceadúnaithe. Mar aitheantas den chás deacair margaidh ina bhfuil an uile chonraitheoir agus go háirithe, oibreoirí beaga, thug an PSA isteach socrú suiteála dóibh siúd ag a bhfuil láimhdeachas níos lú ná €150,000 sa bhliain.

Baineadh amach garsprioc shuntasach in 2010 nuair a eisíodh na chéad cheadúnais conraitheora um Airgead faoi Bhealach. Léiríonn seo buaic infheistíochta suntasaí agus uasghrádaithe ag soláthraithe um airgead faoi bhealach lena gcuid seirbhísi a ardú chuig caighdeán an PSA. Thug an PSA an cháipéis Cheanglas le haghaidh suiteáil CCTV chun críche mar chuid den réiteach le haghaidh cheadúnú na seirbhíse áirithe slándála sin.

Leanann monatóireacht ar siúl ar an uile cheadúnas PSA agus cúlghaireadh ceadúnas 22 conraitheoir. As iad seo, cúlghaireadh 19 gcinn de bharr gur teipeadh orthu na caighdeán cheadúnaithe a choinneáil. Ní furasta don PSA ceadúnas soláthraí a chúlghair agus bíonn orthu dul i gcomhairle le creatlach chomhairlí agus bhealaí ar dtús le cur ar chumas an

chonraitheora an sárú a chur ina cheart. Ar an iomlán, chuir an PSA túis le 73 gníomh den sórt sin i leith conraitheoirí mar aon le breis agus 300 i leith daoine.

Rinneadh imscrúdú ar breis agus 850 ionad le seiceáil a dhéanamh ar cheadúnú aonair agus ar chaitheamh an tsuaitheantais aitheantais. Tá feabhas suntasach tagtha ar chomhlíonadh ceadúnú aonair agus is ionann seo agus 95% le haghaidh gardáil slándála agus 85% le haghaidh slándáil dorais. In ainneoin na leibhéal seo de chomhlíonadh, is ann go fóill do shaincheist le caitheamh an tsuaitheantais aitheantais – caitheann 89% den fhoireann ghardála agus 69% den fhoireann dorais an suaitheantas. Níl na leibhéal seo inghlactha agus cuireadh túis le clár athimschrúduithe ina ndéanfar sprioc d'ionaid neamhchomhlíontacha agus curfear ceadúnais iad siúd a aimsítear a sháraíonn an reachtaíocht ar fionraí nó déanfar iad a ionchúiseamh.

Baineann ríthábhacht le caitheamh an tsuaitheantais aitheantais le muinín an phobail a ardú sa tionscal, a fhad agus atá ceadúnas ag an bhfoireann. Ina theannta sin, cuireann an suaitheantas pointe tagartha ar fáil le haghaidh gearáin sa chás gurb ann do shaincheist leis an tslándáil a cuireadh ar fáil. B'ann do mhéadú in 2010 ar an líon gearáin fhoirmiúla a fuair an PSA, ach i dtromlach na gcásanna, dhiúltaigh an gearánaí a bheith aitheanta agus níor ghabh an gearán ar aghaidh níos faide. Díreoidh an PSA níos mó air seo in 2011.

D'ainneoin an mhéid seo, b'ann do líon imscrúduithe suntasacha faoinar thug an PSA ar a ngluaiseacht féin agus is ann do shampla de na cásanna seo sa Tuarascáil Forfheidhmithe. I measc na gcásanna tá cásanna ina gcinntítear go bhfuil ceann de na fostóirí is mó gardála 100% comhlíontach leis na ceanglais cheadúnaithe, trí chomhoibriú leis an nGarda Síochána agus ceadúnas duine a chur ar fionraí ag a bhfuil ceadúnas slándála dorais a cúisíodh le cionta éagsúla; ionchúsimh éagsúla i leith suiteálaithe neamhcheadúnaithe aláraim i ndiaidh faisnéis a fháil ó fhoinsí tionscail faoi ghníomhaíocht neamhcheadúnaithe. Áirítear le hathbhreithniú cáis na bliana seo, freisin, cuntas ar an idirghníomhú le leachtaitheoir a ceapadh le cuideachta cheadúnaithe gardála slándála. Sa chás seo, d'fhéach an tÚdarás lena dheimhniú gurbh ann do leachtú dlisteanach na cuideachta agus freisin gur aistríodh na conarthaí ina dhiadhbh sin chuig soláthraithe ceadúnaithe slándála.

Ar bhonn oibriúcháin, ba mhian liom an comhoibriú agus an tacaíocht a aithint a fuaireamar ón nGarda Síochána le linn gníomhaíochtaí laethúla ár gcuid iniúchóirí agus na háiseanna a chuir

Oifig Grinnfiosrúcháin an Gharda Síochána ar fáil trí iarratasóirí ar cheadúnais a ghrinnfiosrú. Ar an gcuma chéanna, ba mhian liom an cúnamh a aithint a thug na Coimisinéirí loncaim dúinn trí oibriú an Mheabhráin Tuisceana atá ann eadrainn. Sa mhullach air sin, ba mhaith liom an tacaíocht a aithint a thug an tAire Dlí agus Cirt agus Athchóirithe Dlí agus foireann na Roinne, ag a bhfuil feidhm lárnach i gcinntiú go bhfuil an chreatlach riachtanach reachtúil i bhfeidhm a bheidh mar bhonn agus taca le rialú.

Ar deireadh thair, ba mhian liom iarrachtaí leanúnacha foireann an PSA a aithint mar aon lena nuálaíocht leanúnach i rialú atá éifeachtach ó thaobh costais de a sholáthar don tionscal. I ngeall ar a gcuid iarrachtaí, tugadh isteach scanadh Aithint Optúil Carachtar ('Optical Character Recognition') le haghaidh an uile fheidhmchláir ceadúnais aonair, gníomh a chumasáigh athnuachan 2007/2008 a dhéanamh leis an tríú cuid d'foireann a bhí ag teastáil le linn na tústreimhse sin. 




