# Wearing Your Identity Badge

Section 30 of the Private Security Services Acts 2004 and 2011 provides that a licence-holder must wear an identity badge while providing a security service. The following requirements must be followed when wearing your identity badge:

- The front of the identity badge showing the photograph and licence number must be displayed;
- The badge may be displayed in a card holder or protective armband provided the view of the card is not obstructed;
- The identity badge must be clearly visible at all times and displayed on the upper torso (above the stomach and below the neck). It should never be hung from a belt or obstructed by a jacket, tie or other clothing;
- The identity badge must refer to the person wearing it. It is a criminal offence to wear a badge belonging to another person;
- The wearing of photocopies of the identity badge is not allowed;
- It is recommended that, where a member of the public expresses a wish to make a mental or written note of the licence number on the licence card or ID badge worn the wearer should afford the requestor sufficient time to make such a note, without surrendering or handing over the licence card or ID badge to the requestor.



Our Inspectors regularly visit licence-holders at their place of employment to ensure that these requirements are complied with. Failure to comply with the requirements can result in a warning issuing against the licence-holder and in the case of a second breach of the requirements it may result in the suspension of the licence. You should ensure that you comply with these requirements at all times

All licensed Door Supervisors, Security Guards and Cash-in-Transit operatives are required to wear an identity badge while working and comply with the above requirements.

If you have a licence that expires on either of the dates above you should register for your renewal well in advance of the expiry date. Renewals for these dates will be issued with the new 3 year licenses.

## **Garda Vetting and Licence Renewals**

All licence holders who hold a licence over a number of years are re-vetted on a regular basis. Our policy is to re-vet licensees at least once every 5 years. To this end a certain percentage of licensees are selected randomly and requested to complete a Garda Vetting form.

This is not to be taken as an indication that the PSA has some "information" about the person regarding criminal convictions. It just means that the person's name has been chosen at random to undergo the vetting process again. We appreciate your continued cooperation with this vetting policy and ask you to complete the forms as quickly as possible and return them to the PSA without delay. Licence holders who fail to complete and return the vetting form risk having their licence suspended or revoked.
