E.R.O.

The Employment Regulation Order for the private security industry has been in force since 1st June 2017. It was introduced by Statutory Instrument (SI 231 of 2017) and governs the pay and certain conditions for operatives in the security industry. The Statutory Instrument can be viewed <u>here</u>.

The PSA licensing standard PSA28:2013, requires contractors to comply with legally enforceable legislation in relation to pay rates and conditions, among other relevant legislation. The PSA has commenced inspections to ensure that all licensed contractors are complying with the ERO requirements and will take action against those found to be non-compliant.

Online Contractor Renwal System

We have recentely launched our contractor renewal systems which allows contractors to renew their licence online. This should reduce the administative burden associated with the renewal process. Feedback from those who have already used the system has been positive.

In advance of your licence expiry date you should receive an email from us providing you with details of the renewal process and your password to access the system. If you have any difficulty with the new process please contract our Contractor Licensing Unit at contractors@psa.gov.ie.

PSA Radio Campaigns

Our latest radio campaign highlighted the importance of using licensed private security personnel and ran the last week in September on national radio.

Our next radio campaign was commissioned to stress the importance of using licensed contractors to install intruder alarms and is scheduled to be run the end of October on national and local radio stations.

ENFORCEMENT STATISTICS FOR QUARTER 3, 2017

In the months July, August and September of 2017, the PSA commenced 233 enforcement cases. 145 of these remained active at the end of the quarter. Cases older than 90 days are kept under constant review. Because of the complexity of some investigations, cases can remain open for considerable periods of time. In addition, 318 security employees were interviewed, of which, 98% were licensed.

Next Renewal Dates:

The next dates for renewal of individual licences are –

October 14 and November 26 - 2017

If you have a licence that expires on the above date you should renew your licence online in advance of the expiry date. **All renewals must be made online at** https://renewals.psa.gov.ie

Employers please note that you are responsible for ensuring that your employees hold current licences for the sectors you operate in. If you are found to have unlicensed employees, including employees whose licences have expired, you may face prosecution and/or suspension of your licence.

Cheque Payment No Longer Accepted:

Since October 1st, the PSA no longer accepts payment for individual licences by cheque. All payments must now be made through our online application systems. The number of cheques being received by the PSA has reduced considereably in recent years as our online services have been expanded. As licensing volumes increase we can no longer provide the resources to support a cheque payment service.
