Annual Report for 2019

The Minister for Justice, Helen McEntee TD, welcomed the publication of the PSA's 2019 Annual Report on 4th November. Minister McEntee noted the importance of the work of the Authority in licensing and regulating the private Security industry whilst also acknowledging the considerable impact which Covid-19 has had on the security services industry.

Revocation of Security Guarding Licences with no training

Because of the unavailability of training courses between April and August 2020, the PSA allowed new applicants to the Static Guarding Sector to obtain a licence on the understanding they would complete the training within 3 months of the return of training courses

Licence holders who availed of this derogation were reminded of their obligation to complete the training when courses became available again on August $\mathbf{1}^{\text{st}}$. This gave licence holders until until October $3\mathbf{1}^{\text{st}}$ to complete the training requirements for licensing.

A number of licence holders have not met this requirement to date and will this week be issued with the PSA's proposal to revoke their SGS licences.

Enforcement Focus

Enforcement works closely with An Garda Síochána, Revenue, Department of Employment Affairs and Social Protection, Workplace Relations Commission, training providers, industry representatives and other government agencies to ensure that individuals and companies operating within the private security industry comply with the law. During the period, January 1st to September 30th, 2020, the PSA commenced 531 Enforcement cases to ensure compliance with the licensing regulations.

One example of PSA working with a unit of An Garda Síochána:

The PSA received information from an anonymous report that an 'undocumented person was working within the security industry' and using another individual's PSA License identity. Following an investigation we found a PSA licence card with a photograph cello-taped over the original valid photograph. The Regional Inspector immediately contacted the Garda National Immigration Bureau (GNIB) who are currently investigating the matter.
