Employment Regulation Order in the Security Sector

A new Employment Regulation Order (ERO) for the Security Industry, was approved by the Minister for Enterprise, Trade and Employment in April, 2021 and was due to come into force from September 1st 2021.

Following legal proceedings in the High Court challenging the underlying legislation the Department of Enterprise, Trade and Employment has issued a notice to inform all employees and employers in the Security Sector that until such time that these legal issues have been resolved, the statutory minimum rates of pay and other terms and conditions in the sector will remain unchanged.

Cash-In-Hand and Illegal Employment in the Security Industry

The PSA is investigating reports of illegal cash-in-hand payments to door supervisors and security guards. It is perfectly legal to be paid cash provided your employer has issued you with a payslip and has deducted income tax and PRSI from your payment. Employers are also required to record all cash payments made to employees and to provide details of staff and payments to the Revenue Commissioners.

The PSA works closely with the Revenue Commissioners to ensure that PSA licensed contractors are tax compliant. Non-compliance with tax matters are grounds for taking action against a PSA licence. If a contractor is found to be paying cash-in-hand to staff without returning same to the Revenue Commissions the PSA will consider suspending or revoking the contractor's licence.

The PSA also has a Memorandum of Understanding in place with the Department of Social Protection which allows for the sharing of information relating to both licensed contractors and licensed employees.
