# **Private Investigators**

**From November 1**<sup>st</sup> **2022**, all individuals working as Private Investigators will be required to hold a licence issued by the PSA. The cost of this three year licence will be €90. Applicants can apply online at <a href="www.psa-gov.ie">www.psa-gov.ie</a> nearer the introduction date.

The PSA will hold a forum meeting of all licensed Private Investigator contractors on **Tuesday, October 18**<sup>th</sup> **2022** in the Killeshin Hotel, Portlaoise from 10.30 am to 12.30 pm. The focus of the meeting will be the introduction of employee licensing to the sector.



## **Enforcement Focus**

**During the period January 1**st **to August 30**th **2022**, the Private Security Authority (PSA) commenced **584** enforcement cases to ensure compliance with the licensing regulations, as relevant.

We undertook **73** contractor inspections, carried out **73** unannounced compliance inspections on **627** licensed premises, and **167** investigated buyer of security cases.....

## **Updated Auditing Guidelines for PSA 74:2019**

The PSA 74:2019 Auditing Guidelines have been updated to include the requirement for <u>client agreement prior to the remote access of Electronic</u>

<u>Security Systems</u>. The updated document is available <u>here</u>

The following details the clauses which have been amended:

#### • 3.5 Organisation Information

 Clause 3.5.2(g) "agreement by client required prior to any remote access of electronic security system"

#### • 6.1 Security

- Clause 6.1.7 "Any remote access to a client's electronic security system should not be undertaken without the written permission of the client"
- Clause 6.1.8 "records of all access to a client's system on a remote basis shall be kept for a minimum of 3 years"
