### **Garda Vetting – Children and Vulnerable Persons**

If you provide a security service at a hospital, residential service, leisure or sporting centre, school or childcare service you should clarify with your client if vetting in accordance with the National Vetting Bureau (Children and Vulnerable Persons) Act 2012 is required. If required, your client should arrange for the vetting to be completed. The PSA does not vet people for compliance with the National Vetting Bureau (Children and Vulnerable Persons) Act 2012.

Any queries on the matter should be addressed to the provider of the types of work/activities listed in the Act. The information note <u>PSA 56</u> has more details.
